INDONESIA MARKET WRAP

EQUITY MARKET

Closing Higher

JCI slightly strengthened and closed at 7,378 (+28 points or +0.38%) today. Shares across regional markets were negative. Meanwhile, foreign investors recorded net outflow of IDR 317Bn today and rupiah slightly weakened to IDR 15,798/USD.

Banking stocks were mostly positive as BMRI (+2.84%), BBRI (+2.04%), BBNI (+1.28%), and PNBNI (+5.96%) all up, except BBKA (-0.25%). Consumer names were positive as KLBF (+2.36%), UNVR (+1.47%), MYOR (+1.97%), ICBP (+0.67%), and INDF (+0.39%) all rose. Material stocks were positive as TPIA (+4.85%) and BRPT (+2.65%) all in green. Pulp & paper names were positive as INKP (+3.48%) and TKIM (+1.39%) all in green. Other movers were PNLF (+16.54%), PANI (+3.29%), ELTY (-10%), and WSBP (-10%).

Bank Indonesia (BI) reported that the national banking industry's third party funds reached Rp 8,193tn as of Feb24, growing 5.4% YoY lower than 5.8% YoY in Jan24.

BOND MARKET

LITTLE CHANGE

JCI slightly strengthened and closed at 7,433 (+12 points or +0.16%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 1.9Tn today and rupiah was stabilized at IDR 15,582/USD.

Banking stocks were mixed as BBKA (+3.25%) and BMRI (+1.72%) in green, while MEGA (-3.83%), BBNI (-1.2%), and BBRI (-3.91%) retreated. Consumer names were mixed as INDF (+1.98%), ICBP (+1.63%), and KLBF (+0.7%) advanced, while MYOR (-1.25%) and UNVR (-1.1%) retreated. Mining stocks were positive as ADRO (+2.69%), PTBA (+2.86%), ANTM (+1.54%), ITMG (+1.48%), and INDY (+3.93%) all in green. Material names were mixed as BRPT (+0.98%) up, while TPIA (-10.84%) declined. Other movers were DSSA (+15.48%), MEDC (+9.02%), BRIS (-4.91%), and PANI (-3.67%).

Consumer optimism is decreasing ahead of the Ramadan momentum, as indicated by the decline in the Consumer Confidence Index (CCI) based on the results of the Bank Indonesia Consumer Survey. On Feb-24, the CCI was recorded at level 123.1, down from Jan's level of 125.

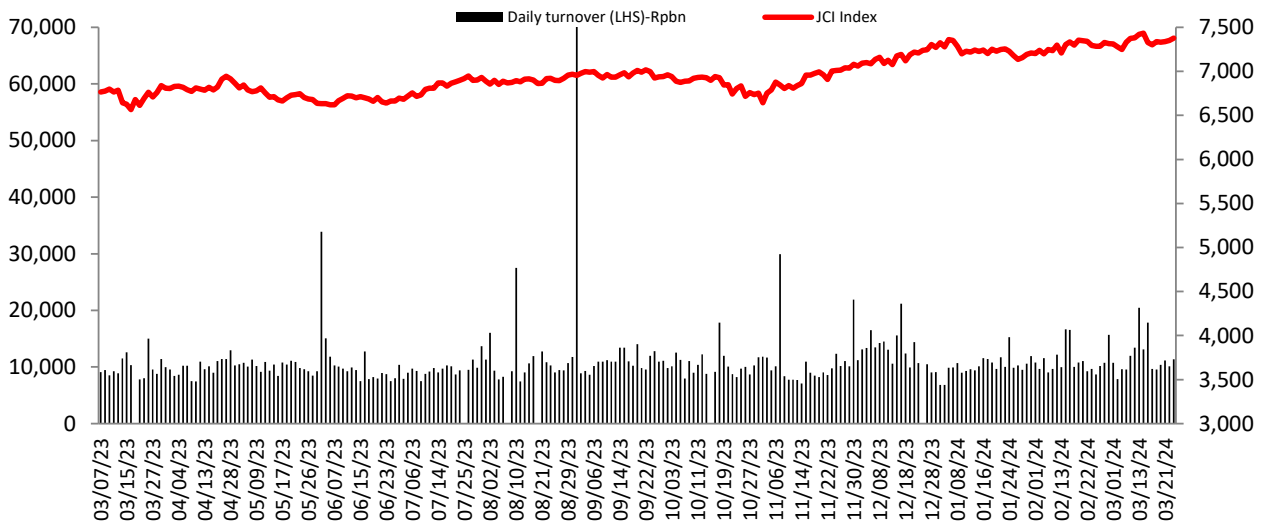

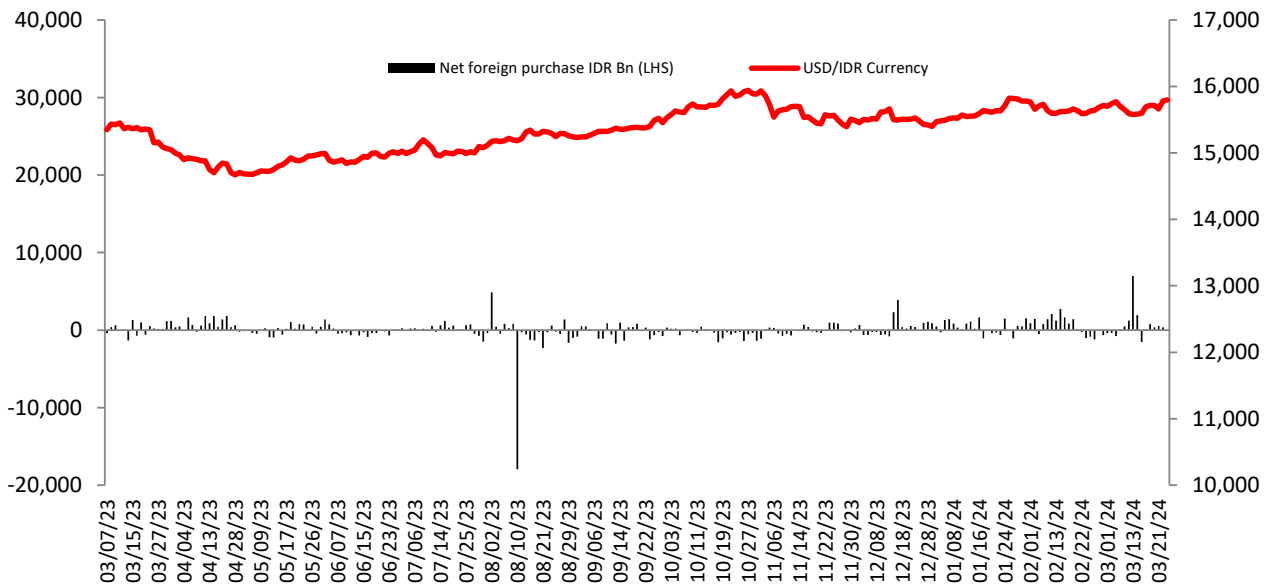
