INDONESIA MARKET WRAP

EQUITY MARKET

BETTER

JCI slightly strengthened and closed at 7,108 (+28 points or +0.39%) today. Shares across regional markets were mostly positive. Meanwhile, foreign investors recorded net inflow of IDR 430Bn today and rupiah slightly weakened to IDR 16,360/USD.

Banking stocks were mostly positive as BMRI (+2.17%), BBRI (+1.71%), BBNI (+2.04%), and MEGA (+2.69%) all advanced, except BBKA (-0.51%). Consumer names were mixed as ICBP (+1.39%) and UNVR (+2.88%) up, while HMSP (-0.81%), KLBF (-1.59%), and INDF (-1.62%) declined. Retailer stocks were negative as ERAA (-1.56%), MAPI (-0.73%), MAPA (-9.8%), and AMRT (-2.81%) all closed lower. Material names were positive as TPIA (+1.12%) and BRPT (+0.53%) all up. Other movers were PTRO (+4.72%), BFIN (+2.27%), JSPT (-18.36%), and EMTK (-5.31%).

Bank Indonesia (BI) recorded the banking industry's loan growth of 10.39% YoY in 2024. Working capital loans, investment loans, and consumption loans grew by 8.35% YoY, 13.62% YoY, and 10.61% YoY, respectively.

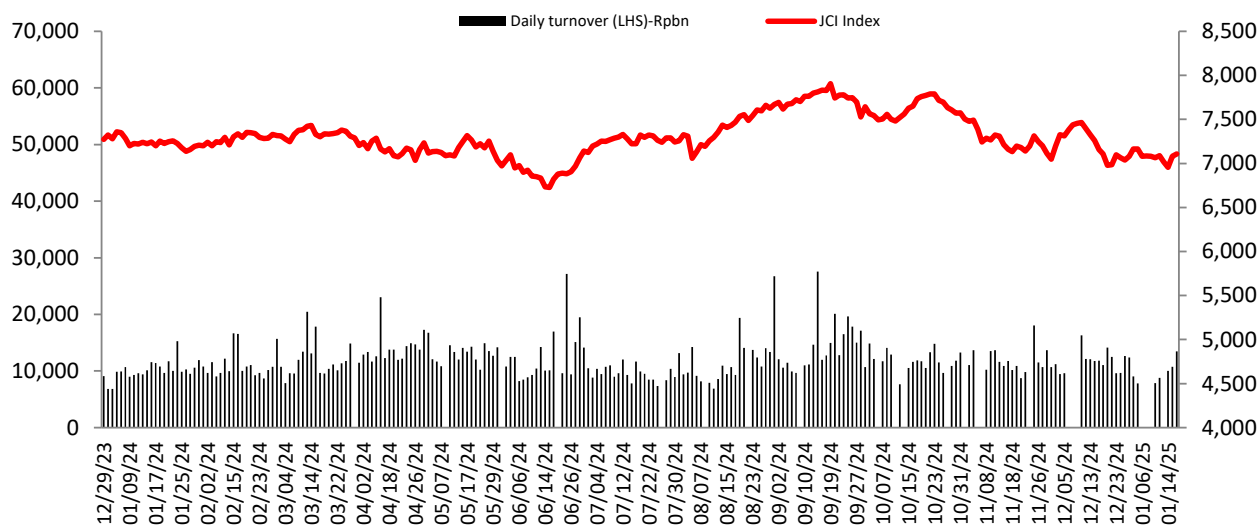

EXTENDED BUYING

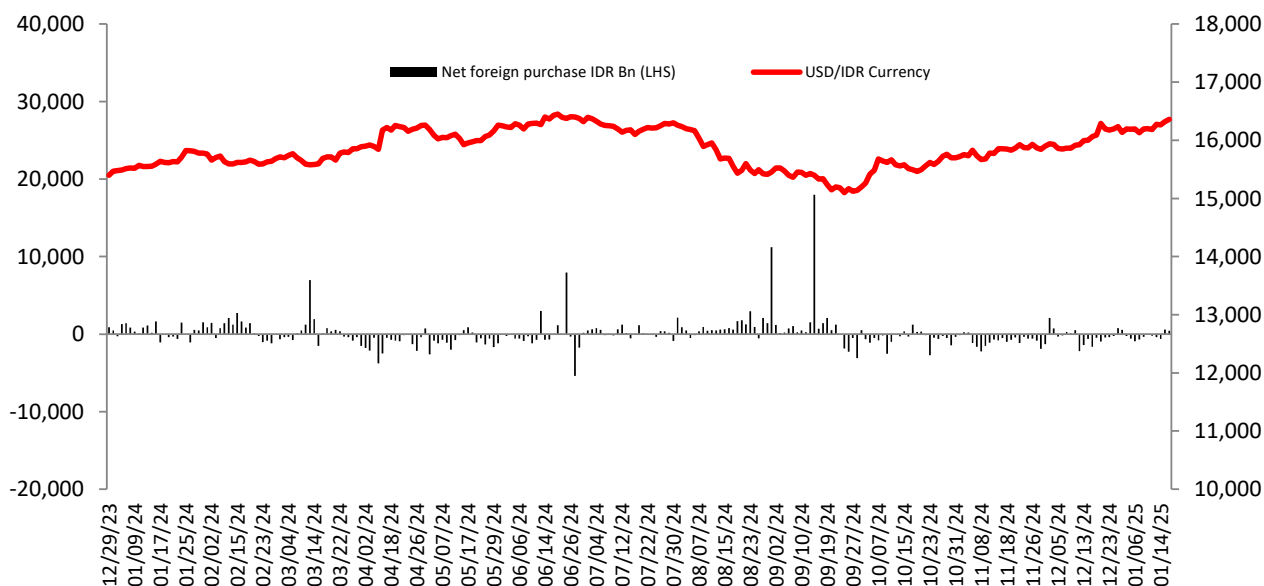
Post softer US CPI last night, the bond market advanced further today on the back of solid interest from both offshore and foreign banks players. Buying boosted prices level across the board. Overall sentiment was bullish across the curve despite local currency touched above 16,400. However, bond prices movement was quickly capped by profit takers. Overall, bonds yield shifted lower by 4 – 10 bps. Nearing market closed, MoF just announced slightly lower auction target at IDR 26T, or IDR 2T lower from last conventional bond auction.
