INDONESIA MARKET WRAP

EQUITY MARKET

Higher Again

JCI slightly strengthened and closed at 7,253 (+32 points or +0.45%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 558Bn today and rupiah slightly strengthened to IDR 16,278/USD.

Banking stocks were mostly positive as BMRI (+2.8%), BBKA (+1.27%), BBRI (+0.21%), and PNBK (+4.94%) all inched higher, except BBNI (-0.21%). Consumer names were mixed as KLBF (+1.36%), INDF (+0.82%), and ICBP (+0.49%) inched higher, while UNVR (-0.34%) and HMSP (-1.36%) retreated. Properties stocks were positive as CTRA (+3.1%), SMRA (+2.91%), BSDE (+0.52%), and JRPT (+0.79%) all advanced. Hospital names were mixed as MIKA (+3.06%) and HEAL (+3.08%) rose, while SILO (-0.36%) closed lower. Other movers were PNLF (+7.45%), SMSM (+5.12%), BSIM (-4.52%), and ARTO (-3.46%).

The budget for ministries and agencies has the potential to increase in 2025. This follows the Ministry of Finance receiving a proposal for additional central government spending amounting to Rp598.9 trillion.

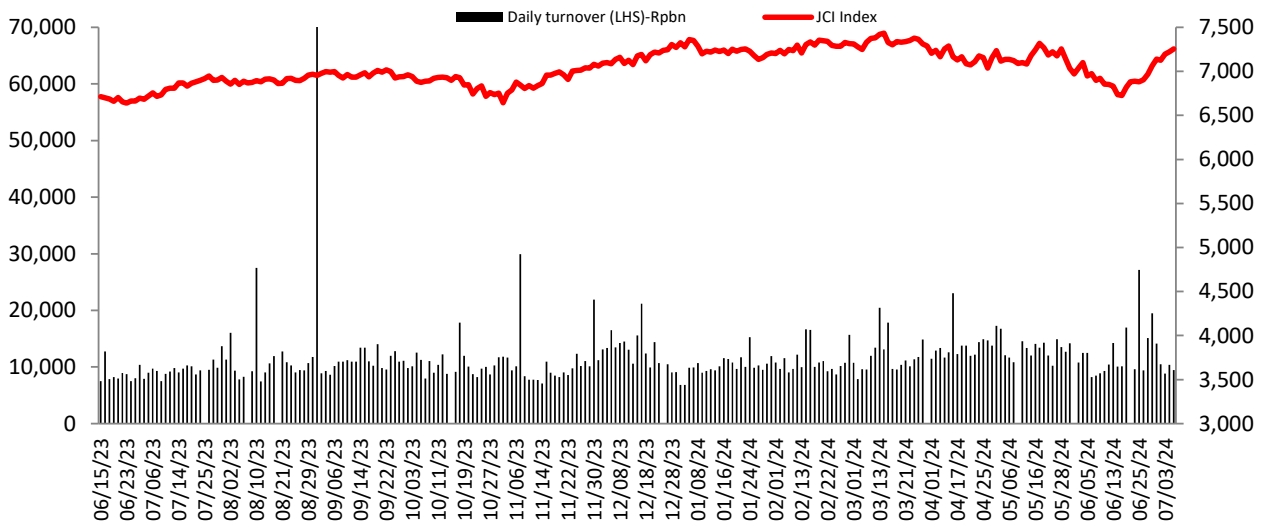
BOND MARKET

Unchanged Sentiment

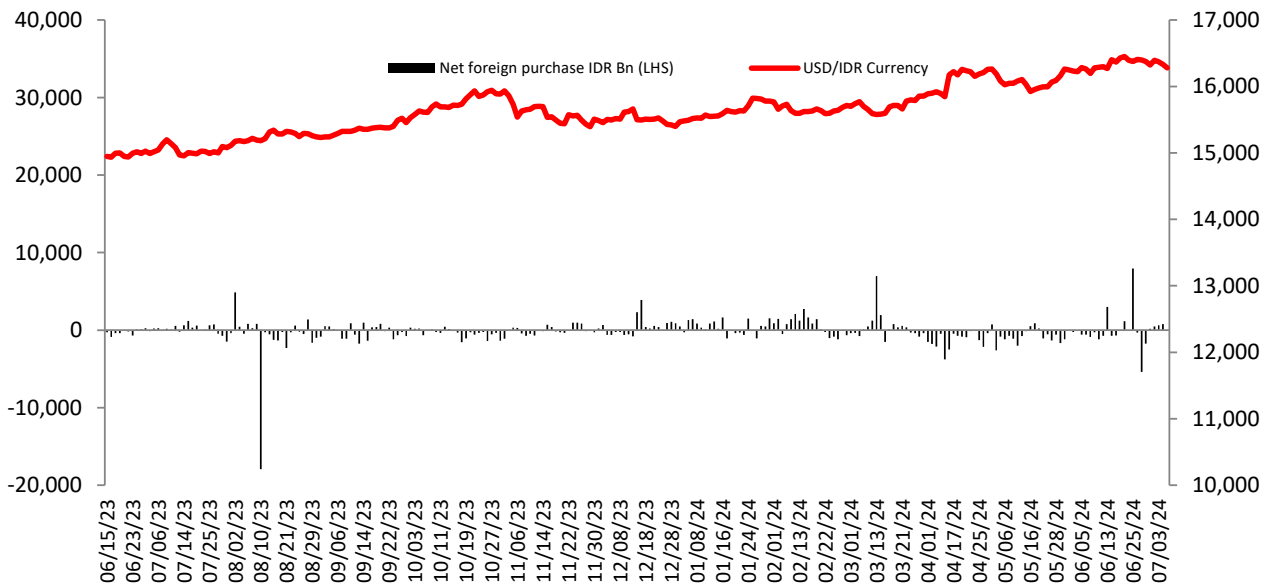
Indonesia bond market closed the week with unchanged sentiment. Market is still moving two ways in the morning session, although in the second session bond market was pretty quiet. Trading concentrated on front to middle maturities while the other part of the yield curve was quoted within range throughout the day. IDR bond the prices ended the day unchanged from yesterday level. The 5Y/10Y/15Y/20Y benchmark closed the week at mid yield of 6.92%/7.03%/7.06%/7.12%.
