Objectives and Investment Policy

The Fund seeks to increase the value of its assets over the medium term by investing in shares of small European companies.

It is actively managed and as such may invest in securities that are not included in the index which is MSCI Europe Small Caps (NR).

The investment team applies also BNP PARIBAS ASSET MANAGEMENT Sustainable Investment Policy, which takes into account Environmental, Social and Governance (ESG) criteria in the investments of the Fund.

Income are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days).

- Why is the Fund in this specific category?

The risk category is justified by the investment in small capitalisation companies that are likely to be subject to a higher than average volatility due to a high degree of concentration, greater uncertainty because less information is available, there is less liquidity, or due to greater sensitivity to changes in market conditions (social, political and economic conditions)

• The higher the risk, the longer the recommended investment horizon.

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- Liquidity Risk: This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.
- <u>Operational and Custody Risk</u>: Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.
