DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Trending upward

JCI advanced and closed at 7,257 (+62 points or +0.86%) today. Shares across regional markets were mostly positive. Meanwhile, foreign investors recorded net inflow of IDR 451Bn today and rupiah slightly weakened to IDR 15,925/USD.

Banking stocks were mostly positive as BMRI (+0.74%), BBNI (+1.99%), BBRI (+0.21%), and PNBN (+0.86%) all rose, except BBCA (-0.73%). Consumer names were positive as ICBP (+2.05%), INDF (+0.8%), KLBF (+0.6%), SIDO (+1.43%), and HMSP (+0.78%) all in green. Material stocks were positive as TPIA (+1.45%) and BRPT (+0.97%) all inched higher. Poultry names were negative as MAIN (-9.66%), JPFA (-3.63%), and CPIN (-1.43%) all corrected. Other movers were BIPI (+12.9%), BHIT (+9.52%), MMLP (-4.12%), and MAPA (-1.81%).

Government extended safeguard duties imposed to import products like carpet, fabrics, and textiles covering for 3 years. This is done to protect and increase the competitiveness of local textile based product. The extension of duties is under PMK No 48 2024 and PMK No 40 2024

BOND MARKET


FLAT

Indonesia bond market closed the week relatively flat today. We saw mixed trading although bond market general direction was biddish with several profit takers came to market. However, there was no significant price movement in the market with only limited trading was seen. Market was mostly dominated by local banks perhaps affected by the SG holiday. The 5Y/10Y/15Y/20Y benchmark closed the week at mid-yield of 6.59%/6.76%/6.87%/6.93%.


