DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Rally

JCI advanced and closed at 7,360 (+81 points or +1.11%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 1.3Tn today and rupiah was stabilized at IDR 15,490/USD.

Banking stocks were positive as BMRI (+4.1%), BBRI (+1.79%), BBNI (+4.67%), BBCA (+1.34%), and MEGA (+1.44%) all advanced. Consumer names were mostly positive as ICBP (+4%), INDF (+0.78%), HMSP (+1.69%), and MYOR (+1.24%) all rose, except KLBF (-0.93%). Mining stocks were mostly positive as ADRO (+2.07%), PTBA (+4.74%), ITMG (+3.3%), and INDY (+6.64%) all closed higher, except ANTM (-0.88%). Material names were positive as TPIA (+0.85%) and BRPT (+1.11%) all rose. Other movers were CASA (+21.79%), BRIS (+5.28%), RAJA (-6.01%), and GOOD (-3.56%).

The Ministry of Finance reported that realization of energy subsidies reached Rp164.3tn in 2023 (89% of FY23 outlook, -4% YoY). For 2024, the energy subsidy budget is set at Rp189.1tn (-11% from 2023 budget).

BOND MARKET


MIXED INTEREST

Indonesia bond market traded weaker today as 10Y UST hit 4% last night. As soon as market opened, offerish tone was seen especially on belly and around 20Y areas. However, we saw several bottom fisher collecting at better yield and provided some support to the market. From then on mixed interest still continued but nearing INDOGB market closing time, 10Y UST yield touched 3.9% hence bringing the yield curve 3 – 4 bps lower than yesterday closing level. Total foreign ownership went up to IDR 842.05Tn on Dec 29 2023, from previously IDR 762.19n on Dec 30 2022.


