INDONESIA MARKET WRAP

EQUITY MARKET

Another Correction

JCI weakened and closed at 7,027 (-158 points or -2.19%) today. Shares across regional markets were negative. Meanwhile, foreign investors recorded net outflow of IDR 814Bn today and rupiah slightly weakened to IDR 17,000/USD.

Banking stocks were mostly negative as BNLN (-1.03%), BBNI (-0.54%), BBRI (-0.9%), and BMRI (-1.48%) all weakened, except BBCA (+1.15%). Material names were negative as TPIA (-8.95%) and BRPT (-12.33%) all weakened. Mining stocks were negative as ITMG (-1.62%), PTBA (-2.35%), INCO (-4.35%), TINS (-6.37%), and ANTM (-1.89%) all retreated. Consumer names were mixed as INDF (+0.76%) and UNVR (+1.05%) inched higher, while HMSP (-0.68%), ICBP (-0.34%), and KLBF (-1.02%) retreated. Other movers were MSIN (+24.63%), BHIT (+5.88%), BUVA (-10.91%), and DEWA (-7.33%).

Headline inflation moderated by 1.28pp to 3.48% YoY in March (4.76% in February), against consensus expectations of 3.64%. Core inflation also moderated by 0.11pp to 2.52% (2.63% in February), below consensus estimates of 2.64%

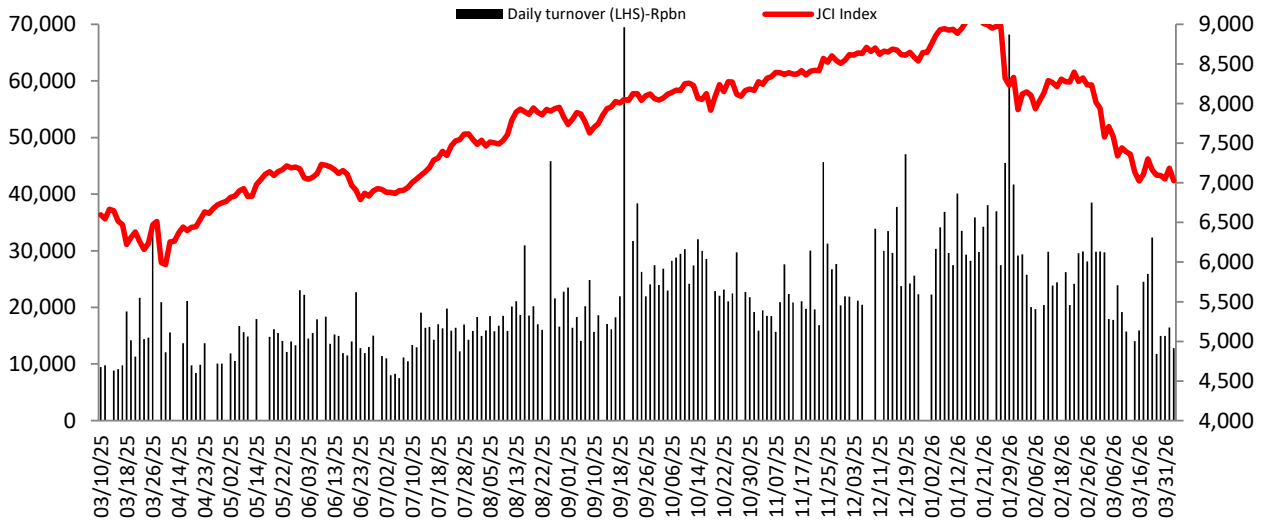
BOND MARKET

Cautious

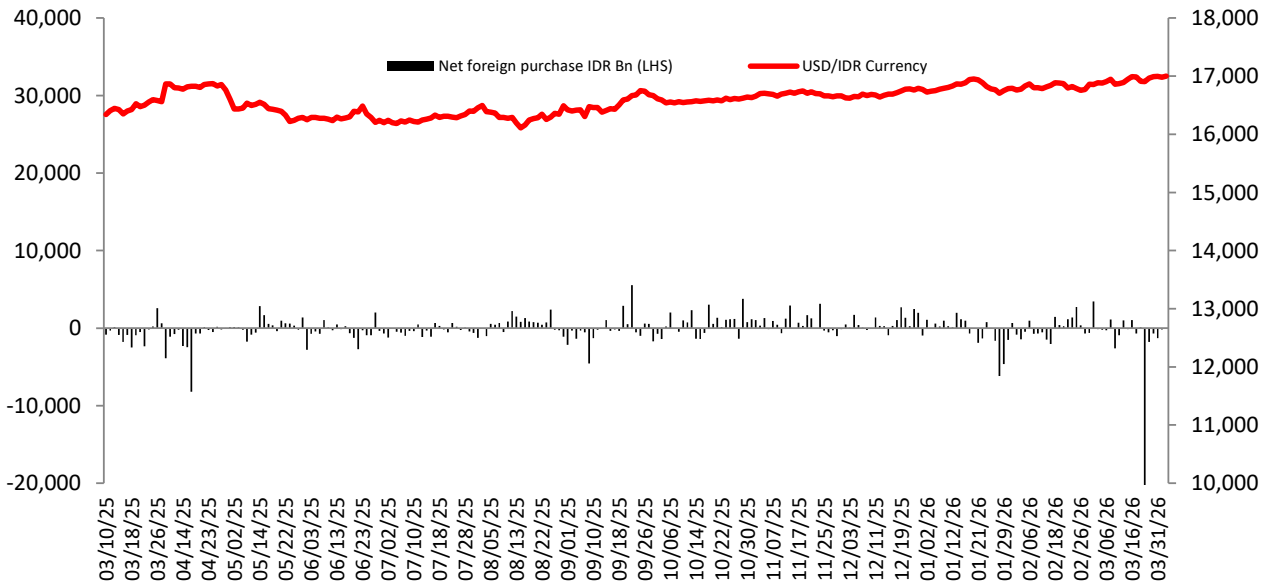
Indonesia bond market weakened today, with yields moving higher amid renewed global uncertainty and profit taking following recent rally. Rupiah remained relatively stable above 17,020 while sentiment turned cautious. Market closed with yields higher by 3 – 8 bps compared to yesterday closing level. The 5Y/10Y/15Y/20Y benchmark closed the week at mid-yield of 6.46%/6.62%/6.80%/6.81%.
