DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Mixed

JCI slightly strengthened and closed at 7,199 (+11 points or +0.15%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 211Bn today and rupiah slightly weakened to IDR 16,273/USD.

Banking stocks were mixed as BBRI (+1.16%), BBNI (+0.67%), and BNLI (+3.4%) in green, while BMRI (-1.37%) and BBCA (-1.82%) declined. Consumer names were mostly positive as KLBF (+3.29%), ICBP (+0.91%), INDF (+0.32%), and GGRM (+1.75%) all rose, except UNVR (-1.42%). Material stocks were positive as BRPT (+10.66%) and TPIA (+0.51%) all advanced. Telco names were positive as TLKM (+1.07%), ISAT (+2.87%), and EXCL (+0.46%) all inched higher. Other movers were TBIG (+10%), ADRO (+9.57%), RAJA (-5.09%), and BRMS (-4.76%).

The Minister of Cooperatives is targeting the establishment of 80k Village Cooperatives 'Merah Putih' by the end of June 2025, and it is expected that all will be launched by July 12, 2025, during the National Cooperatives Day.

BOND MARKET


Sukuk Auction

It was a dull day for the bond market with relatively thin trading volume. After open the day unchanged, bond prices moved nowhere throughout the day as we heard hardly any trade done. In today sukuk auction, MoF was received demand with only a total of IDR 24.79Tn incoming bids out of which MoF downsize the issuance in the amount of IDR 8Tn (initial target IDR 10Tn). The series absorbed (against incoming bids) on the auction were IDR 0.8Tn (IDR 1.235Tn) 6mo SPN-S, IDR 0.95Tn (IDR 4.576Tn) 9mo SPN-S, IDR 2.7Tn (IDR 6.104Tn) 2Y PBS3, IDR 0.4Tn (IDR 5.113Tn) 4Y PBS30, IDR 0.1Tn (IDR 2.84Tn) 13Y PBS34, IDR 2.1Tn (IDR 2.156Tn) 16Y PBS939, and IDR 0.95Tn (IDR 3.219Tn) 24Y PBS38 at cut off yields of 5.95%, 6%, 6.31%, 6.37%, 6.89%, 7% and 7.02% respectively.


