## Objectives and Investment Policy

The Fund is an index-tracking passively managed fund.


The Fund seeks to replicate (with a maximum tracking error\* of 1%) the performance of the FTSE EPRA Nareit Eurozone Capped (NTR) index (Bloomberg: NROEUE Index) (the «index») by investing in shares issued by companies included in the Index, respecting the Index's weightings (full replication).

\*The tracking error is a risk indicator that measures how closely a fund tracks the performance of its reference index.

A dividend may be distributed on a quarterly basis.

Investors are able to redeem on a daily basis (on Luxembourg bank business days)

# Risk and Reward Profile



- Historical data may not be reliable indication for the future.

- Why is the Fund in this specific category?
- The risk category is justified by the investment mainly in Stocks and Shares, the value of which can fluctuate considerably. These fluctuations are often amplified in the short term.
- The higher the risk, the longer the recommended investment horizon.

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- <u>Liquidity Risk</u>: This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.
- Operational and Custody Risk: Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.

- (\*\*) The **entry** and **exit charges** on the primary market are not applicable on the secondary market.


