INDONESIA MARKET WRAP

EQUITY MARKET

Lower

JCI weakened and closed at 7,224 (-55 points or -0.75%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 530Bn today and rupiah was stabilized at IDR 16,180/USD.

Banking stocks were mostly negative as MEGA (-0.4%), BBNI (-0.9%), BBCA (-1%), and BBRI (-1.87%) all declined, except BBTN (+1.47%). Consumer names were mostly negative as HMSP (-1.4%), INDF (-0.42%), ICBP (-0.95%), and UNVR (-4.1%) all declined, except KLBF (+0.32%). Telco stocks were mixed as ISAT (+1.97%) advanced, while FREN (-3.03%) and TLKM (-1.9%) weakened. Mining names were mostly positive as INCO (+2.98%), ITMG (+1.76%), TINS (+3.59%), and PTBA (+0.4%) all rose, except ANTM (-0.74%). Other movers were KPIG (+10.48%), MAPI (+5.62%), MPRO (-13.85%), and ASII (-2.01%).

The disbursement of people's business credit (KUR) as of 1H24 reached Rp141.85 trillion, or 47.3% of the total KUR 2024 budget of Rp300 trillion. Absorption in 1H24 increased by +34% YoY.



SUKUK AUCTION


Indonesia bond market opened the day unchanged. In the morning session, bond market remain quiet. However, in the afternoon session, market took a turn following 10Y UST yield traded at yield below 4.2%. From our side we heard trade done in 10Y FR100 was traded at 97.9 (6.92%). The yield closed the day higher by around 2 – 5 bps. In today sukuk auction, government received solid demand totaling at IDR 27.71Tn. MoF managed to issued at IDR 10Tn. The series absorbed (against incoming bids) on the auction were IDR 0.6Tn (IDR 2.19Tn) 6mo SPN-S, IDR 0.55Tn (IDR 3.33Tn) 9mo SPN-S, IDR 1.1Tn (IDR 9.93Tn) 2Y PBS32, IDR 5.5Tn (IDR 6.97Tn) 4Y PBS30, IDR 0.3Tn (IDR 0.39Tn) 13Y PBS4, IDR 0.1Tn (IDR 0.2Tn) 17Y PBS39 and IDR 1.85Tn (IDR 4.7Tn) 25Y PBS38 at cut off yields of 6.85%, 6.93%, 6.84%, 6.83%, 7%, 7.04% and 7.16% respectively.
